- c. The photo must clearly display the full price on the screen. Entrants must retain their receipt which matches this exact price paid.
 - d. One itemised receipt per entry. Entrants will be required to provide an itemised receipt that states the time and date of purchase, as this is required for validation and in order for the winner to receive their Prize. unable to drive due to a disability or medical condition but wishes to own a car for a carer to use for the winner's benefit.

evidence of identity and eligibility (including receipt as proof of purchase). Reasonable efforts will be made to contact the provisional winner. Once eligibility has been confirmed, the provisional winner will be confirmed as a winner and accept the Prize.
